It rules on individual or State applications alleging violations of the **civil and political rights** set out in the **European Convention on Human Rights**.

**Begging** - Lăcătuș v. Switzerland

**Right to education**

Szolcsán v. Hungary

# Inclusion - some lessons learned



**Make environment more inclusive - Introduce Roma history in school curricula**

**Have their voices heard - meetings(RP), conferences, workshops**

**Joint working groups - local action plan - PARTICIPATION**

**Sustain NGO start-up**

**Raise awareness - positive narratives, positive image in the media (cooperate)**

**NGO support in EU court**

**Use judgements from courts to put pressure on governments**

**Quality education - competences + work together with all stakeholders**

**Create facilities/ programmes open to all - needs assessment, tailored measures**
